

# Here are some practical tips on how to be a great neighbor.

**Get to know your neighbors:** Meet your neighbors if you haven't already done so. Let them know that you're there to help, if they ever need another hand.

Smile and wave if you see a neighbor when they're outside. It's easy to have a conversation in your neighborhood if you spend time in your garden or front porch or simply take a walk.



Form a neighborhood group by exchanging contact information. It's nice to have someone to text to pick up a package from your porch that unexpectedly arrived while you were on vacation.

And remember, if you see something suspicious, say something. The Bellevue police ask you to call 911 or the non-emergency number - 425-577-5656.

Follow the laws and Association rules: Do not set off private fireworks, which are both illegal and present a fire danger.

Put all yard waste in green bins. Please do not dump or blow leaves or other yard waste into your neighbor's yard or into landscape buffer areas.

Take care of your pets: Make sure your pets are not a nuisance or a menace to the rest of the neighborhood. For example, don't leave a dog who continually barks outside in your backyard for hours at a time.

When cleaning up after your dog, take the dog waste bags back to your home to put in your own garbage container.Your neighbor's trash bin out at the curb is *not* a place to put your dog's waste.

Maintain your property: Keep your lawn cut, your shrubs and trees properly pruned, and your home's exterior clean and tidy.

Take down your holiday lights after the holiday season is over.

Keep shrubs away from sidewalks to allow pedestrian access. Follow City of Bellevue rules and keep street trees pruned off the sidewalk and the road.

Keep vehicles parked in the garage or your driveway, not on the street.



### Help Keep Our Community Healthy and Beautiful

PLEASE SCOOP the POOP! (and put the bag in the garbage) It is "unlawful for anyone with custody of an animal to fail to remove any fecal matter deposited by the animal on public property or private property of another." BCC8.05.040 (& a violation of CC&R 6.4)

### Please Be a Good Pet Owner

Dogs <u>MUST</u> be leashed at all times (under CC&R 6.4 & Bellevue City Code BCC 8.05,030).

Roaming dogs create messes in yards, parks, and playgrounds. Not to mention scaring those afraid of dogs and are at higher risk of being hit by a vehicle.

### **Design Review Board Requests**

Design Review Board (DRB) requests, for *any change* to the exterior of a house or the lot, including all fences, roofs, heat pumps, AC, landscaping, and painting should be submitted through MacPherson's Community Management's AppFolio Owner's Portal, under the "Architectural Reviews" tab.

Please remember the DRB meets on the 3rd Wednesday every month and materials MUST be submitted <u>by</u> <u>5 PM</u> on the 2nd Friday of each month. # **Lakemont Board in Action**

- **Monument Signs** The monument signs are due to be replaced between the end of April and beginning of May.
- Mailbox kiosk The Chandler Park kiosk is due to be painted shortly.
- Irrigation Irrigation repairs, discovered during spring start-up, are almost completed.
- Monument Beds Spring/summer color installed and all beds mulched.
- Main Entry Main entry redesigned and new Maple tree and bulbs installed in upper bed.
- Mulch, Replanting, & Cleaning on SE 55<sup>th</sup> St East side mulched and Pieris plants replanted, and plant debris removed on the lower west side.
- Power Washing Sidewalks Cleaning and moss removal on 600 feet of sidewalk on the east side of SE 55<sup>th</sup> St, the ramp by Carlyle monument, and between SE 55<sup>th</sup> St and 173rd Ave SE on Village Park Drive.
- **Community Tree Maintenance & Removals** 2025 pruning and limb removals throughout all of Lakemont completed.
- Wyngate Monument Dead and dying Arborvitae behind the lower Wyngate monument removed.









### Remember - Animals Love Lakemont Too!

Bears love our garbage and leaving your can out on any day other than garbage day can become a lovely dinner party for hungry bears. Unfortunately, they will spread the garbage throughout the neighborhood as well as the surrounding forested areas. There have been recent bear sightings and easily accessed garbage is what keeps them coming back for more.

Many other wild animals also call this area home, including raccoons, deer, <u>cougars</u>, <u>coyotes</u>, <u>bobcats</u>, crows, and squirrels. Please don't feed them or leave sources of food or garbage cans available for them.



Washington Fish and Wildlife Service notes, "the number one reason for conflict, (95% of the calls to offices) is the result of irresponsibility on the part of people: Access to trash, pet food, and bird feeders." Be aware, negligently attracting bears is against the law in Washington (RCW 77.15.790-792). Please do your part to keep our community and the bears safe.


# **Street Trees**

The trees located in the "planter strip between the sidewalk and the street" along the front or side of a lot, <u>are to be</u> <u>maintained by the Lot owners.</u> [DRC 7.9 (c) & 10.6(d) -"Installation and maintenance is the responsibility of the lot owner."]

Additionally, per the City of Bellevue "Property owners are asked to help keep streets and sidewalks safe and clear for walkers and bicyclists" by trimming back tree branches and shrubs that overhang the street or sidewalk.

(see https://bellevue.municipal.codes/BCC/14.06.010.)

The City provides this handy graphic to explain the required clearance of 14 ft along the roadways and 8 ft along the sidewalks. Additionally, all shrubs need to be kept trimmed back off the sidewalk.



### Please be sure to trim back branches and suckers on and around the street trees as they:

"obstruct or impair the free and full use of the sidewalk or street by the public . . . or which have grown or died upon any property and are a fire hazard or a menace to public health, safety or welfare are a public nuisance. It is the duty of the owner of the property wherein or whereon any such nuisance exists or of the property abutting the street wherein or whereon such nuisance exists to abate the same by trimming, destroying or removing such growing or dead growth. (1961 code § 10.20.010.)"

### **City of Bellevue Tree Ordinances**

How are trees regulated in the City of Bellevue? [Note: The rules changed as of July 2024]

"Removal of <u>any</u> trees that meet the following conditions <u>WILL</u> require a permit for tree removal:

- **any landmark tree**. A landmark tree is at least 24 inches in diameter (75 inches in circumference), measured four feet above the existing grade.
- **any significant trees**. A significant tree is at least six inches in diameter (19 inches in circumference), measured four feet above the existing grade.
- a tree in a designated critical area, buffer or structure setback (per Land Use Code 20.25H).
- a tree on commercial or multifamily zoned property
- a tree is **in a native growth protection area or** <u>a retained vegetation area</u> easement or tract.

see <u>City of Bellevue Tree Removal Requirements.</u>

In addition, see the new detailed <u>replanting requirements</u> at the Clearing and Grading Code, <u>Chapter</u> <u>23.76,060 BCC</u> (emphasis added). Also note: 23.76.150 - "Every contractor or other person working **or directing work** must have a permit before and on site during work." City of Bellevue is holding owners responsible for ensuring permits are obtained.

### **Commonly Asked Questions:**

#### IS IT OKAY FOR US TO LEAVE OUR GARBAGE AND RECYCLING BINS IN THE DRIVEWAY OR IN FRONT OF OUR GARAGE?

While the Association understands that garbage cans can take up a lot of space inside your garage, they are not permitted to be visible from the Association's streets. CC&R 6.7 states that "trash, garbage, and recycling containers shall not be permitted to remain in public view except on days of trash or recycling collection." If you don't want them in the garage, tuck them into your back or side yard, out of view. But remember they also need to be secured against the bears.

#### WHAT CAN I DO ABOUT TREES BLOCKING MY VIEW?

If the trees are on your property, **and** not in a <u>Retained Vegetation Area (RVA</u>), you may trim them back, in compliance with City of Bellevue ordinances. If they are in an RVA, you need written approval by the City and the DRB before pruning or removal. If they are on your neighbor's property, you need to work out an agreement with your neighbor (see additional information and instructions in the *Policy for Resolving Individual Residential Disputes*). If they are in a <u>Native Growth Protection Area (NGPA)</u> contact the City of Bellevue - Maryann Olson (molson@bellevuewa.gov). If they are in a <u>Landscape Buffer area (LBA)</u>, you need to follow the instructions outlined in the *Policy for Implementing Requested Changes to the Landscape Buffer Area*. All documents are accessible on <u>AppFolio</u>.

#### WE ARE PLANNING ON CHANGING SOME OF OUR LANDSCAPING. DO WE NEED TO GET APPROVAL FIRST?

*Before* starting *any* landscaping project, you will need to submit a sketch, drawing, or landscaping architect's plan of exactly what you are planning to change in your yard. Please be as specific as possible, including tree and shrub heights, plant varieties, and locations of installations. Requests can be submitted on the Community forum - <u>AppFolio</u> - in the "Architectural Review" tab.

#### WHAT DO WE NEED TO DO IF WE ARE THINKING ABOUT REPAINTING OUR HOME?

If you are repainting your siding and trim <u>the same colors</u>, you do not need prior DRB approval. But if you are changing any of the colors, then you need to submit a request along with the new brand and color. The DRB meets on the 3rd Wednesday of each month and requests need to be submitted by 5 pm of the preceding Friday. Requests can be submitted on the Community forum - <u>AppFolio</u> - in the "Architectural Review" tab.

#### CAN WE JUST REPLACE OUR GUTTERS OR GARAGE DOORS?

If the gutters remain <u>the same style and color</u>, you are free to replace them. If you want to install a different gutter system or color, you need to submit a DRB request. If you are changing your garage door from a wooden paneled door to aluminum (or another material), adding windows, or changing the color of the garage door, then you need to submit a prior DRB request. Requests can be submitted on the Community forum - <u>AppFolio</u> - in the "Architectural Review" tab.

# WHO DO WE CONTACT FOR AN ASSOCIATION IRRIGATION LEAK, PLANT/TREE ISSUE, BURNED OUT MONUMENT LIGHTS, OR ANY OTHER EMERGENCY?

#### WHO IS RESPONSIBLE FOR THE PARKS, TRAILS, AND THE TUNNEL UNDER VILLAGE PARK DRIVE?

The City of Bellevue maintains the trails and parks within and surrounding Lakemont. They maintain the bridges, trails, walkways, and tunnel under Village Park Drive. If there is an issue with vegetation, graffiti, or irrigation, please reach out to Maryann Olson at <u>molson@bellevuewa.gov</u> or submit a report/request for action via the MyBellevue App or the <u>MyBellevue website</u>.

#### WHAT DO I NEED TO DO TO CHANGE MY INDIVIDUAL OR CLUSTER MAILBOX?

Each mailbox is the responsibility of the individual owner(s). All owners with boxes on a mail kiosk must agree in writing and submit a request with the approvals and an image of the chosen model to the DRB in order to change individual boxes to a locking cluster system or to change an existing locking system.
